- 1) All championship dogs must be purebred & registered on DogsNZ Register Part 1.
- 2) Full pedigree name and registration number must be supplied at time of entry.
- 3) All competitors and dogs compete at their own risk.
- 4) Engraving to be the responsibility & cost of the winner.
- 5) NZGTA Rules & Regulations will be available at the Secretary's office.
- 6) The committee reserves the right to replace judges and change grounds in unforeseen circumstances.
- 7) Eight or more dogs to be entered for third place trophy to be awarded
- 8) Shotguns will not be used in this trial (unless otherwise noted on the schedule). An alternative firing device will be used.
- 9) Retriever Walk Up A ballot will be held at the Tai Tapu Pub on the 1st Oct 2025 at 6:30pm if required. The draw for order of running will be made at the Captain's briefing.
- 10) Spaniel Natural Game this event will be a maximum of 20 dogs. If entries exceed 20 dogs, the club will hold a ballot at the Tai Tapu pub on the 2nd Oct 2025 at 6.45pm. The draw for order of running will be made immediately after the ballot.
- 11) Any dog who misses out on the ballot will receive a refund of their entry fees.
