- 5) NZGTA Rules & Regulations will be available at the Secretary's office.
- 6) The committee reserves the right to replace judges and change grounds if unforeseen circumstances.
- 7) Eight or more dogs to be entered for third place trophy to be awarded
- 8) Shotguns will not be used in this trial. An alternative firing device will be used.
- 9) Retriever Walk Up – A ballot will be held at the Tai Tapu Pub on the 13th Nov 2025 at 6:30pm, if required. The draw for order of running will be made at the Captain's briefing.
